Old Business

Reading and Approval of Minutes from the Last Meeting. The 2021-05-06-Annual-Meeting Minutes.pdf were previously distributed to the Unit Owners and a motion to waive the reading of the minutes and approve the minutes as presented was made by Barb Harris, 15 Birdie Drive and seconded by Jerry Mann, 23 Fairway Drive.

The motion passed without objection.

New Business

Board of Directors Election

Amanda Hudson conducted the primary purpose of the meeting which was the election of five (5) Board of Directors to serve one year terms on The Fairways Condominium Unit Owners Association, INC Board. Said terms to be effective starting June 1st, 2022.

After asking if there were any additional nominations from the floor for director other than those listed on the ballot, and hearing none, a motion to close further nominations from the floor made by John Porterfield 79 Fairway Drive and seconded by Louann Holmes, 13 Birdie Drive was accepted.

The motion passed without objection.

The motion passed without objection.

Vote to Waive the Fully Funded Reserve Requirement

After considerable discussion on the budget and reserve requirements there was a written ballot to vote:
